# Introduction

The purpose of this booklet is to showcase contributions from the participants of the *Breaking Through* seminar that took place in Berlin between 5.–14.6.2023. *Breaking Through* is a seminar about spreading awareness and finding creative ways to increase knowledge and understanding of LGBTQI+ rights. In this Erasmus+ project, SCI German branch collaborates with SCI Catalunya, SCI Greece, SCI Switzerland, PVN Albania, ISRKA and Alternative-V Ukraine. In June, we brought together 15 colourful people from different backgrounds for 10 days in Berlin to delve into the topic in a fully self-organised setting.

Throughout the seminar the participants created multi-method visual and performance-based art projects that focus on storytelling from queer and trans perspectives. With these art projects as a basis, we created a series of workshop proposals, that can be of use in educational settings and trainings to promote LGBTQIA+ rights, representation, and visibility. Additionally, the flip book includes summaries of participants' presentations from their home countries, introducing local realities of LGBTQIA+ communities in Greece, Pakistan, Spain, Switzerland, and Ukraine.







These specifically cater towards topics to do with gender, sexuality, and LGBTQIA+ rights. The workshop scripts can be used as they are or modified according to different groups' needs. We ask to credit the original creators in case workshop scripts are used in other trainings or publications.

# Queer stories with shadow puppets



### When shadows become alive in queer history

**Purpose**: To adapt a queer story for children. This activity is designed to communicate queer stories in a visual manner from different cultures and countries.

**Objective:** To spread the love and the momentum, beyond western stories. To honor the queer stories that do not belong mainstream western culture.

**Method:** Approach and reach out to people who know about the story. Respect the culture.

#### Main activity:

- 1. Read about the story and history.
- 2. Create a story line on a page by visualizing the story.
- 3. Find music that reflects the story.
- 4. Write a script
- 5. Create puppets using papers, milk boxes and any type of cardboards.
- 6. Prepare dark room for the shadow.
- 7. Do rehearsal 2-3 times, before the final performance

#### **Materials**

Papers, tapes, pencils, pens, markers, charts, lights, cell phones flash, tapes, tables, scissors, dark room, laptop, multimedia device.

#### Roles

- 3-4 people to manage puppets
- 1 person to manage music
- 1 person for script (voice over).

# The Tale of Bulleh Shah:

Once, a very long time ago there was a child named Bulleh Shah. He was born in a very religious family and one day his father said "You will be an Islamic scholar one day, you should go to Lahore to learn more about Islamic Religion". Bhulleh agreed and he went to Lahore and meet his master and future lover, Inayat Shah, they were mesmerized of each other and fell in love. But there was a problem, Bulleh was from the Syid family and Inayat form Arain family wich means they had a cast difference, what became a burden for both of them.

The news of their love, spread in the town. People started gossiping and both Inaya and Bulleh, had an argument. Anaya said to Bulleh: "Go back, go away, your family is against us, you have to leave"

And then they decided not to live together. Bulleh was really sad, he knew that he didn't want to leave his master, his beloved. He became a dancer, started dancing to please his master, he danced for 12 years doing a dance called: The Twirling dance. After this 12 years, Anaya obeyed Bulleh's demands to stay together and they lived for 30 years.

Interaction Activity

Names: Dimitrios Vlachos, Elektra Papadopoulou Vasilarou, Alesja Mateli

Title: Cavafy's poem group learning

Intro: The person we would like to talk about is the gay poet Konstantinos P. Kavafis (Cavafy). Through this activity, people could read some of his most important poems (Ithaka, Waiting for Barbarians, The city, One night). The next step would be to interact with the people that chose the same poem and share the same or different feelings. At the end, everyone can share their poem to the whole group.


Aim: Share feelings and why they connected with these lines of a poem. Being vulnerable and sharing first in small groups and then in the whole group.

Goal: Learn about social pressure and passenger apathy and LGBTQIA+ discrimination in general, through art, diachronic (timeless) poems. So people can explore the work of queer people.

Instructions: 1. Choose for poems of Cavafy and select 4 quotes by each (5 minutes)

- 2. Write these quotes into different papers (1 paper for each quote, without including the title of the poem) (10 minutes)
- 3. Divide people in 4 groups with a maximum number of 3-4 in each group (2 minutes)
- 4. Everyone chooses the quote they resonate with (3 minutes)
- 5. The facilitators divide people into new groups according to the quote of the poem they choose. Now we have 4 new groups, every group with the same poem. We also give them the whole poem so they understand better (1 minute)
- 6. Each person in the group expresses their connection to this quote or the whole poem and all together find the same feelings and similarities (10 minutes)
- 7. Everyone makes a circle again and each group shares their feelings and emotions about the poem. So now everyone can hear for every poem (10 minutes)

Outcome: Visual outcome of prototype











Problems/barries: 1. Many people, we need to remind everyone to be quiet (Solution: group leaders and generally facilitators to say "be quiet")

- 2. Time problems, sometimes the time is not enough or too much. (Solution: We can adjust + or 2 minutes, but we need to remind them it's a 10 minute task. We also remind them when they have 5 and 2 minutes. At the end ask if everyone finished and maybe add 2 minutes)
- 3. Maybe too academic. Everyone had fun but there was a lot of speaking and discussing. (Solution: Remind everyone to have fun, speak their truth, that it is an open and safe space to share)
- 4. Right poems or not? There is always a fear that these poems are not ideal or not enough, maybe it takes more time to find the perfect romantic poems.
  (Solution: more time and more communication to find the perfect poems, for example people can add the poem "Remember Body")

Result: Everyone is vulnerable and open to discuss feelings. People also understand how social pressure and passenger-by empathy was 200 years ago and check the similarities or differences.

Closure: We thank everyone for being so open to discuss and have a dialogue about something so important and deep.



**TOPIC:** Family Gender Pressure

**TARGET AUDIENCE:** Can be done in seminars and trainings.

**GROUP SIZE:** Suitable for small groups

**ALLOCATED TIME: 30 minutes** 

**METHOD:** Self-reflection

MATERIALS NEEDED: A pile of books.

**INTRODUCTION:** 5 minutes

Please note that this activity is sensitive to personal experiences, so it's essential to create a safe and supportive environment for participants to share if they choose to do so.

Set up a start line and a finish line. Place a pile of books behind the start line.

MAIN ACTIVITY: 15 minutes


All participants stand at the start line with the pile of books behind them.

Read the following statements aloud, and if the statement applies to a participant, they can take a step forward after taking a book. If the statement doesn't apply, they stay in place.

- Take a book if a family member has told you that you have to be more girly/boyish.
- Take a book if a family member has told you to wear clothes that you don't prefer because they are not girly/boyish enough.
- Take a book if a family member has told you that your voice is too girly/boyish.
- Take a book if a family member has told you that your movements or gestures are too girly/boyish.
- Take a book if a family member has told you that you should not engage in activities like cleaning, cooking, or sewing because you are a boy, or that you should not fix or repair things because you are a girl.

After each correct statement, the participant must return the book to the pile and then take a step forward.

Continue reading the statements and allowing participants to step forward accordingly.



**CONCLUSION:** Facilitate a group discussion where participants can share their reflections and experiences related to family gender pressure and how it can be difficult (compare with caring the book and going with them to the finish).

# WHAT IS ACTUALLY BEYOND IN THE SPANISH STREETS? THE TRANS LAW

BY LULU SAUCH & GONZALO GÓMEZ

## Key words: Trans Rights, Self-Determination Law, Queerness, Barcelona, Media Representation

2023 was a big year for Spain's trans legislation as the leftgovernment approved winged long-fighted selfdetermination law which allows trans people over 16 to change their gender oficially without their tutor's the need o f permission, a diagnosis on gender dysphoria, taking hormones or undergo any surgical intervention. This advance in legislation has come by the hand of a rise of trans representation in media, which has put trans realities in the center of social discourse.

Nevertheless, all this heavily contrast with the reality of lots of trans people who are still being kicked out of their assaulted houses, in streets or not having access to education or the workplace. Trans and queer identity in Barcelona are completely linked to race and class fight and that intersectionality is still being widely discussed because it's too dangerous to recognize us all as a cohesive force against human rights violations and capital driven economies and policies.

Although the self-determination law was approved this year, there's still a lot of work to do. We are making progress and can seem like it's enough, but the other side of the coin is that trans people are still facing poverty, marginalisation and violence and that has to be acknowledged.

SUMMARY: GREECE HAS MADE QUITE A FEW IMPORTANT STEPS WHEN IT COMES TO LEGISLATIONS FOR THE LGBTQ+ COMMUNITY. ESPECIALLY THE LAST 20 YEARS, THINGS HAVE CHANGED A LOT. LAWS HAVE BEEN INTRODUCED TO PROHIBIT DISCRIMINATION IN THE WORK PLACE. CIVIL PARTNERSHIP HAS BEEN IMPLEMENTED AND CHANGES IN FAMILY LAW HAVE BEEN MADE. AT THE SAME TIME, NGOS AND INSTITUTIONS PROVIDE SERVICES AND SUPPORT THE COMMUNITY IN A VARIETY OF WAYS. LGBTQ+ COMMUNITY IS BEING REPRESENTED IN THE PARLIAMENT AND POLITICAL SCENE. HOWEVER, INCLUSION AND EQUALITY HAVE NOT BEEN REACHED YET. HOMOPHOBIA AND TRANSPHOBIA STILL EXIST AND HAVE LEAD TO HEINOUS CRIMES IN THE NEAR PAST. ALTHOUGH NUMBERS DESCRIBE AN OPTIMISTIC PICTURE, THE GAP BETWEEN LEGISLATIONS AND LIFE IS STILL BIG.

PROBLEM: ALTHOUGH PROGRESS IN THE LEGAL FRAME IS OBSERVABLE, IT SEEMS THAT IT IS NOT ENOUGH. FROM ONE HAND, THE LEGISLATIONS ARE THERE BUT NOT ALWAYS RESPECTED AND DO NOT GUARANTEE PEOPLE'S SAFETY, WHEN IT COMES TO REAL LIFE.

# Situation of the LGBTQIA+ community in Switzerland

Progress, Harrssment, Organisation, Self-determination law, Conservative, Rainbowscouts, Anti-discrimination law, Same-sex marriage.

Keywords

The situation for LGBTQIA+ people is getting better in Switzerland. There is an anti-discrimination law, same-sex marriage and self-determination of gender. Hate crime is higher than in other countries though, especially for non-cis and gay persons.

Summary
